COLORED STONE REPORTS

GIA Colored Stone Reports describe the type of gemstone, if your stone is natural or laboratory-grown, and if there are any detectable treatments. May be loose or mounted gemstones. For mounted items, the gross weight will be measured in grams and carat weight will be approximated to determine the appropriate fee.

COLORED STONE IDENTIFICATION REPORT (LOOSE OR MOUNTED)

Contains a detailed description of the gemstone such as cutting style, shape, weight, measurement, and color, and includes a photograph of the gemstone. Loose and mounted fees are for items of all cutting styles. For mounted items, the carat weight will be approximated to determine the appropriate fee. Items weighing over 50 kilograms are not accepted for submission. Discount available for additional stones on the same report.

BATCH SERVICES

GIA Batch Services analyze and/or sort multiple gemstones based on varying test types. Minimum stone submissions vary by service. Not available for amber, turquoise or any rough gemstones.

QUALITY ASSURANCE

Up to two test criteria may be requested per submission. Results presented in table format. Test offered when applicable and must be for the same material. Not available for items that have already received an Identification or Identification & Origin Report. For loose gemstones only.

*Testing for beryllium and heat treatment will be performed if required and charged accordingly.
