PEARL REPORTS

GIA Pearl Reports provide information on the identity of pearls (natural or cultured), the mollusk (when determinable) they originated from and the environment they formed in (saltwater or freshwater), and also state whether the pearls have undergone treatment.

PEARL IDENTIFICATION REPORT

Details the quantity, weight, size, shape, color, overtone, identity, mollusk (when determinable), environment and any detectable treatments. Report includes a digital image. Items weighing over 50 kilograms are not accepted for submission.

MIXED PEARLS

Necklaces or strands where standard identification testing shows there is a mix (20% or more of a different "type") of natural and cultured pearls or untreated and treated pearls (specifically modified color) and where the client chooses to separate the pearls rather than opt for a more generically worded report (i.e. stating "contains cultured pearls" or "mixture", etc.). The pearls will be returned loose when necessary.
